Your participation in Ave Maria Academy Scrip Tuition Credit Program means you understand and agree to the following terms and conditions:

- 1. Ave Maria Academy is not responsible for lost or stolen Scrip gift cards once placed in a child's backpack or picked up at the school front desk. We do not track individual Scrip serial numbers. Scrip is to be treated like cash. Protect it!
- 2. Extended family members and friends can participate in the Scrip Tuition Credit Program. Simply have them indicate on their Participant Agreement which family is to receive the tuition credits generated. Extended family members and friends cannot change their tuition credit designee each order period. Please choose one family for the entire academic year. Or, you can include their order with your family's order.
- 3. Scrip deadlines are strictly enforced. Due to short turn-around times, we cannot honor late orders. Orders and payments must be made online using Presto Pay at www.ShopWithScrip.com no later than 3:30 p.m. on the order date. Late orders will be processed during the next Scrip order period.
- 4. All Scrip orders are to be made online at www.ShopWithScrip.com. Payments will deduct directly from your chosen bank account using Presto Pay. **Please note that Scrip is not tax deductible.**
- 5. Scrip tuition credits will be applied against your 2017-2018 tuition. Tuition credits are equal to 50% of the profit generated from your orders. Please review the order form for a list of vendors and their applicable profit or go to the Scrip page of the school website for a link to complete vendor information. Profit percentages change from time to time. We will do our best to communicate changes to you.
- 6. Participant families with their last student in Eighth Grade will have their Scrip credits applied to the General School Fund Account.
- 7. If a student/family leaves Ave Maria Academy during the academic year, tuition credits are forfeited and applied to the General School Fund Account.
